# **Shooting Disciplines**

- 1. **IDPA** Kurt Recapped the Tier 2 Match from October. Asked for permission to hold a Tier 3 match in 2021. They are anticipating 180 shooters. Motion by Dawn to close the Pistol/Rifle ranges from September 28 thru October 3. Shotgun fields will be closed October 2 and 3. 2<sup>nd</sup> by Marc Approved. Kurt questioned the use of steel on 7-8-9–Bob/Jon to discuss and get back with Kurt. Kurt asked for permission to use the side berms on 7-8, Bob advised NOT currently allowed, must continue to use back berms due to the erosion. This can be relooked at in the future. The winner from their 50/50 raffle donated his portion of the funds to our 4H group, Kurt will get the money to either Maynard or Bruce.
- 2. Cowboy area –Dawn –IDES in November, should have approx. 200 shooters. Invited the Board to attend the awards dinner at the Elks Lodge. Plans also underway for IDES 2021.
