- 2. Shotgun- ATA Thanks from Bruce, so far, it's very successful. Had 15 shooters for each of the last 2 weeks. They will be doing various clinics/training. He's been given a few ATA memberships that will be given away.
- 3. Cowboy area –Dawn –IDES in November, should have over 200 shooters, currently at 209. Invited the Board to attend the awards dinner at the Elks Lodge. Plans also underway for IDES 2021.

Treasurer's report was presented by Marc Ouellette – as of September 30, 2020 - Income- \$22421.33, Expenses- \$23570.47 - Total available funds were \$459742.80, including money markets. Detail report posted. Presented September actual versus projected. Provided an update on the 2020 totals, actual versus projected. He's asked for 2021 budget input, we will meet briefly on Sunday, November 8 to discuss and the final will be presented to the BOD at the November 18th meeting for final approval before presenting to the membership in December. - 4. Repair of safety wall Shotgun Field/Range 8 Bob to get estimate from Mossy Oak
- 5. Range Hours Dawn confirmed that the range will continue to remain open late on Tuesday/Wednesday
- 6. Motion and approval to make a donation to the Salvation Army in honor of Jim Brookman's wife that has recently passed away.
- 7. Special BOD meeting held on October 19 Discussion about the purchase of land next door from Loma Linda. In attendance Rick Bill Dawn Marc Carl Ray Jon Sydney Bob. Bill had previously emailed a contract for our review/questions/approval. Bill explained the thought process behind the dollar value being offered.
